- 1. Abstracts should not exceed 3 (three) pages A4 of printed text (incl. drawings, tables and references), typed in MS Word. Headset: Times New Roman, font size -14, line spacing -1.5. Fields: top and bottom -1.5 cm, left -2.0 cm, right -1.0 cm. Paragraph -1.25 cm.
- 2. In the upper left corner is the UDC (font size -14, bold, line spacing -1,0, left alignment). Below is the name and surname of the author/co-author (font size -14, bold, line spacing -1,0, right alignment). Onwards academic degree, title, position, name of the organization (institution), where the author (co author) work (font size -14, bold, line spacing -1,0, right alignment).

In one line in capital letters, title of abstract printed in bold, centered.

Below through one line - the text of abstract, width alignment.

Students' abstracts accepted under condition of redaction of the scientific supervisor only.

- 3. The illustrative materials should be of good quality and of minimum volume.
- 4. References (font size 12, normal, line spacing 1,0, width alignment) made in accordance with National Standards of Ukraine (NSU) 8302:2015. The links given in the text in square brackets. The first number is the link number from the list of references; the second is the page number. A comma separates the link number and page number: [1, 95-96]. A semicolon separates the link numbers: [2; 5; 7].

The authors are responsible for the appropriate degree of the abstracts, the validity of the conclusions, and the reliability of the results.

The Editorial Board has the right to edit provided materials without the author's compliance, as soon as that does not misrepresent the sense of the text, or in terms of inability to harmonize the corrections due to the absence of the author's contact information.
